

Giveaway "50 Lucky Riders" Rules (September 1-30, 2025)

- **1. Eligibility:** This campaign is open to all current and potential Monimoto customers worldwide. Employees of Monimoto UAB, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers (collectively, the "Employees"), as well as their immediate family members or household members, are not eligible to participate. The campaign is subject to all applicable federal, state, local, and international laws and regulations. Void where prohibited.
- **2. Agreement to Rules:** By purchasing a Monimoto 9 device during the campaign period, participants are automatically entered into the giveaway and agree to be fully and unconditionally bound by these rules and the decisions of Monimoto, UAB. Participants represent and warrant that they meet the eligibility requirements. In addition, participants agree to accept the decisions of Monimoto, UAB as final and binding as it relates to the campaign.
- **3. Campaign Period:** Giveaway campaign begins September 1st, 2025 at 12:00 AM (GMT+1) and ends on September 30th, 2025 at 11:59 PM (GMT+1).
- **4. How to Enter:** The campaign is entered by purchasing a Monimoto 9 device from the official Monimoto website (https://monimoto.com/) during the campaign period (September 1-30, 2025). Each order that includes at least one Monimoto 9 counts as one entry only, regardless of the number of Monimoto 9 devices or other items purchased in the same transaction.

Purchases made outside of the campaign period, through resellers, distributors, or via any other channels do not qualify. All eligible orders are entered automatically; no additional registration or steps are required. No other method of entry is permitted.

5. Prizes: Each of the fifty (50) winners (each a "Winner") will receive a one-year Monimoto subscription for one device, which activates after the initial two-month free trial period ends. The approximate retail value of the prize depends on the Winner's location (\$49 / £36 / €39). Actual/appraised value may differ at the time the prize is awarded.

The specifics of the prize are determined solely by Monimoto UAB. No cash alternative or substitution of the prize is permitted, except at the discretion of Monimoto UAB. The



prize is non-transferable. Any and all prize-related expenses, including without limitation federal, state, local, or international taxes, shall be the sole responsibility of the Winner. No requests for the cash equivalent, prize substitution, or prize transfer/assignment are permitted.

- **6. Odds:** The odds of winning depend on the number of eligible entries received.
- **7. Winner Selection and Notification:** A total of fifty (50) Winners will be selected at random under the supervision of Monimoto UAB. Winners will be notified via the email address used for their purchase within five (5) days of selection. Monimoto UAB shall not be held liable if a Winner does not receive the notification due to spam filters, junk mail settings, or the provision of incorrect or non-functioning contact information.

In order to claim the prize, Winners must respond to the notification email within five (5) working days and provide the IMEI number of the newly purchased Monimoto 9 device. The free one-year subscription can be applied exclusively to the Monimoto 9 device purchased during the campaign. Failure to respond within the timeframe or to provide a valid IMEI number will result in forfeiture of the prize, and another Winner may be selected at Monimoto UAB's discretion. Monimoto UAB assumes no responsibility for a Winner's failure to claim the prize under these conditions

8. Terms & Conditions: Monimoto UAB reserves the right, in its sole discretion, to cancel, terminate, modify, or suspend the campaign if technical failures, fraud, unauthorized intervention, or any other cause beyond its reasonable control affects the administration, security, fairness, or proper conduct of the campaign. In such a case, Monimoto UAB may select winners from all eligible entries received prior to and/or after (if appropriate) the action taken.

Monimoto UAB further reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process, website, or otherwise violates these Terms & Conditions.

Any attempt by an entrant to deliberately damage any website or undermine the legitimate operation of the campaign may be a violation of criminal and civil laws. Should such an attempt be made, Monimoto UAB reserves the right to seek damages to the fullest extent permitted by law.

9. Disputes: This campaign is governed by the laws of Lithuania, without regard to conflict of law principles. As a condition of participating, participants agree that any and



all disputes that cannot be resolved between the parties, and any causes of action arising out of or in connection with this campaign, shall be resolved individually, without resort to any form of class action, exclusively before a court of competent jurisdiction located in Vilnius, Lithuania.

Further, in any such dispute, under no circumstances shall participants be entitled to recover punitive, incidental, or consequential damages, including reasonable attorney's fees, other than actual out-of-pocket expenses directly related to participation in this campaign. Participants hereby waive all rights to have damages multiplied or increased.

- **10. Privacy Policy:** Information submitted with an entry is subject to the Privacy Policy stated on the Monimoto UAB website. For winners, the IMEI number provided during prize confirmation will be used solely for the purpose of verifying eligibility and activating the one-year Monimoto subscription.
