



Giveaway “Subscribe and Win Monimoto 9 at Metstrade 2025” – Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility

This Giveaway (“Campaign”) is open only to individuals who sign up at <https://monimoto.com/eu/tradeshow> and who intend to attend the Metstrade 2025 tradeshow in Amsterdam. Employees of Monimoto, UAB, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers (collectively the “Employees”), and the immediate family members or household members of such Employees, are not eligible to participate. The Campaign is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

2. Agreement to Rules

By participating, you (“Contestant”) agree to be fully bound by these Official Rules and confirm that you meet the eligibility requirements. You also agree to accept all decisions of Monimoto, UAB as final and binding in relation to this Campaign.

3. Campaign Period

Entries will be accepted online beginning September 1, 2025 at 12:00 AM (GMT+1) and ending November 12, 2025 at 11:59 PM (GMT+1). All entries must be received within this timeframe.

4. How to Enter

To enter, complete and submit the online form provided at <https://monimoto.com/eu/tradeshow>. Only fully completed entries that meet all Campaign requirements will be eligible. Incomplete or non-compliant entries may be disqualified at the sole discretion of Monimoto, UAB.



Limit one (1) entry per person. Multiple entries using different email addresses, identities, or devices are not permitted. Attempts to circumvent the rules by using fraudulent methods will result in disqualification at Monimoto, UAB's discretion.

5. Prizes

Ten (10) winners (each a "Winner") will each receive one Monimoto 9 device (approximate retail value: €169). Actual/appraised value may differ at the time of award. The prize specifics shall be determined solely by Monimoto, UAB.

No cash or prize substitutions are allowed except at Monimoto, UAB's discretion. Prizes are non-transferable. Any and all prize-related expenses, including but not limited to federal, state, and/or local taxes, shall be the sole responsibility of the Winner.

Prizes must be collected **in person** during the Metstrade 2025 tradeshow, at the Monimoto booth (Hall 7, Booth 210). Prizes not collected during the tradeshow will remain the property of Monimoto, UAB.

6. Odds

The odds of winning depend on the total number of eligible entries received.

7. Winner Selection and Notification

Winners will be selected at random under the supervision of Monimoto, UAB and notified by email within two (2) days of selection. Partially concealed winner email addresses (e.g., moni****@gmail.com) will also be published on the registration landing page (<https://monimoto.com/eu/tradeshow>).

Monimoto, UAB is not responsible for failed or missed notifications due to spam filters, junk mail, incorrect email addresses, or other communication issues. If a Winner cannot be contacted, is found ineligible, or fails to claim the prize within the tradeshow period, the prize will remain with Monimoto, UAB.

Receipt of a prize is contingent upon compliance with all applicable laws and these Official Rules. Any violation, as determined at Monimoto, UAB's sole discretion, will result in disqualification and forfeiture of the prize.

8. Terms & Conditions



Monimoto, UAB reserves the right, in its sole discretion, to cancel, terminate, modify, or suspend the Campaign in case of fraud, technical issues, or any factor beyond its control affects the integrity or proper conduct of the Campaign. In such cases, Monimoto, UAB may select winners from all eligible entries received up to the time of the issue.

Monimoto, UAB also reserves the right to disqualify any individual who tampers with the entry process, violates these Rules, or acts in a disruptive or unsportsmanlike manner. Any attempt to deliberately damage any website or undermine the Campaign may result in criminal or civil liability, and Monimoto, UAB reserves the right to seek damages to the fullest extent permitted by law.

9. Disputes

This Campaign is governed by the laws of Lithuania, without regard to conflict of law principles. As a condition of participation, entrants agree that any disputes that cannot be resolved between the parties shall be resolved individually, without resort to class action, exclusively before a court located in Vilnius, Lithuania. Entrants waive the right to claim punitive, incidental, or consequential damages, including attorneys' fees, and agree that their recovery shall be limited to actual out-of-pocket expenses related to entering this Campaign.
